1.2 General description

The Crab Return System (CRS) is a (semi)-automatic system designed for the user to return the crab easily with the push of a button or an auto return switch. The CRS can easily be installed upon your STR, MRP or VSRX system. The unit will be provided with a basic manual remote control start set. It is possible to add more remote controls or an automatic return switch to the system to create a maximum ease of use out of the CRS.¹

1. Additional remote controls and auto return switch need to be ordered separately

2.1 Product components

The product consists of the following main components and elements:

- CRS unit
 - motor compartment
 - cover plate with pulley wheel
 - CRS Auto Return Switch
 - rope set
 - bracket set crab
 - stop bracket
 - rope brackets
 - remote control
 - fastening material

2.2 Tools and requirements

You need the following tools and requirements to install the unit:

- basic tools
- 7 & 9 mm drill bit
- cordless drill

4.1 Unpacking

 - two eye bolt connector plates with eye bolts (start/stop triggers and eye bolt connector)
 - rope bracket
 - remote control
 - bracket set crab
 - fastening materials

4.2 Mounting instruction

The system is configured in such a way that the motor will pull the crab towards the motor compartment. In case you would like to switch the pull direction, switch the 2 motor leads. See the supplied electrical diagram.

Please note that the side on which the Crab Return System will be mounted is fixed by the design of the motor compartment and placement of the pulley wheels. If the Crab Return System is used with a Pneumatic Grabber®, all required parts that are mounted on the rail and crab for the pneumatic system have to be on one side, and all parts for the CRS on the opposite side. It is advised to draw a layout prior to installation.

4.3 Installation

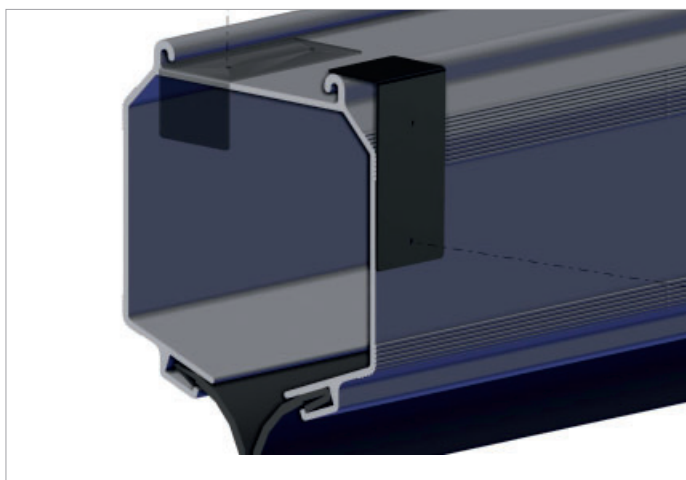


Fig. 4.3.1 Drill template on MRP

- With the use of the drill template, drill four 9 mm holes at the end of the rail. For the holes on the side use the bottom hole of the template. For the holes on the top use the bottom hole on the template. Refer to fig. 4.3.1.
- Repeat this step for the other end of the rail.

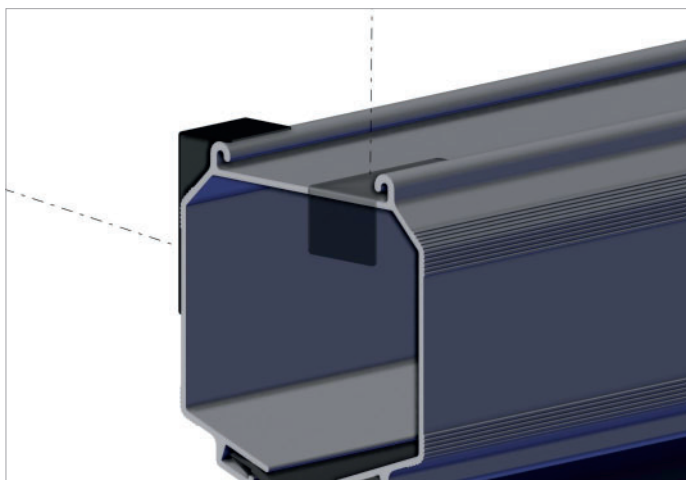


Fig. 4.3.2 MRP drill template

- Attach the motor compartment to one end of the rail and secure with 4x M8x20 bolts and 4x M8 washers using wrench 13 (½ in.).



TIP

Attach the cover plate of the CRS to the rail after the crab has been prepared and installed.

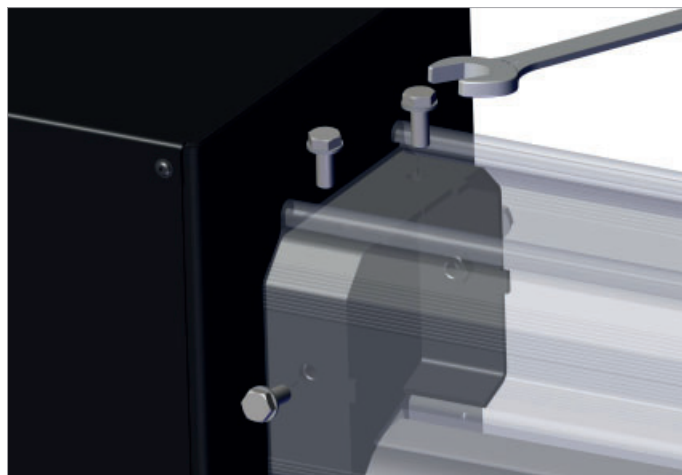


Fig. 4.3.3 Mounting the motor compartment to the rail

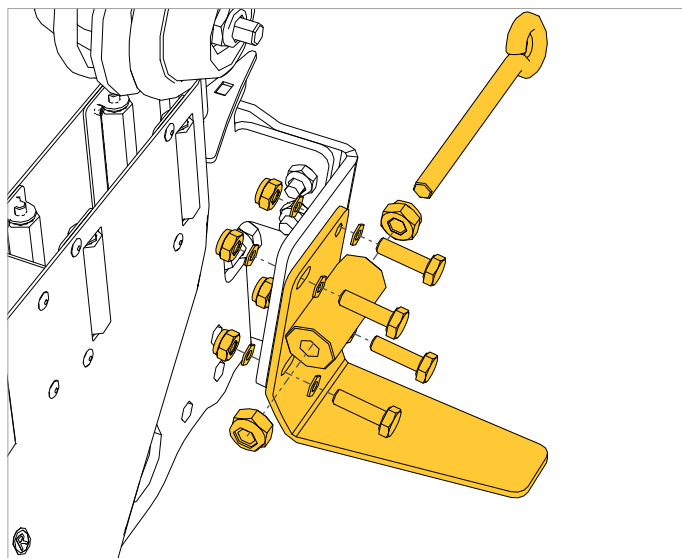


Fig. 4.3.4 Mounting the rope connector plates to the crab

- Attach both rope connector plates to the crab using 4x M4x20 bolts for each bracket. Attach the rope eye bolts with 2x M8 nuts, with the eye facing out. Refer to fig. 4.3.4
NOTE: In the case of an existing system with an older crab, make sure to predrill holes in the crab!

- In case of a new system, put the crab in the rail.

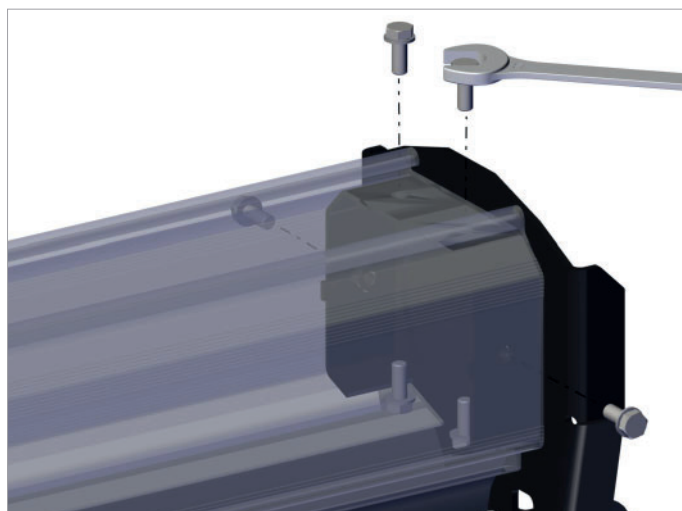


Fig. 4.3.5 Mounting the cover plate

- Attach the CRS cover plate to the other end of the rail and secure with 4x M8x20 bolts and 4x M8 washers using wrench 13 (½ in.). Refer to fig. 4.3.5.

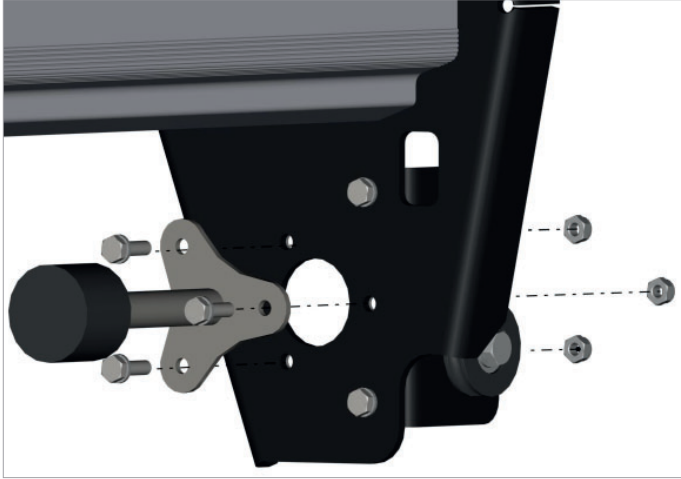


Fig. 4.3.6 Mounting the shock on the cover plate

- Mount the shock (or hydraulic shock absorber) on the coverplate with the provided fastening materials. Refer to fig. 4.3.6

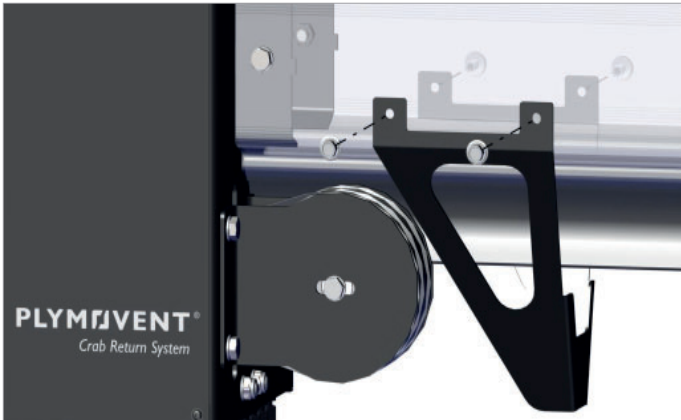


Fig. 4.3.7 Mounting the stop bracket

- Mount the stop bracket to the rail using self-tapping screws $\frac{1}{4} \times 1$ in. (6.3 x 25 mm). Mount the stop bracket 8 in. (200 mm) from the end of the rail. Refer to fig. 4.3.7.

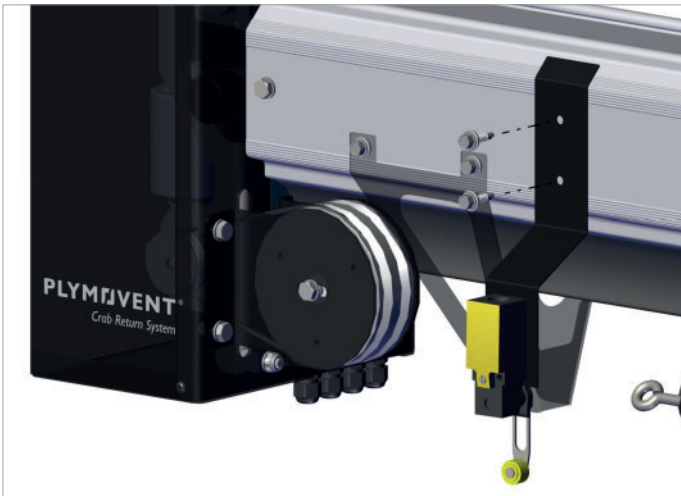


Fig. 4.3.8 Mounting the CRS Auto Return Switch bracket

- Mount the CRS Auto Return Switch bracket at approx. 1 in. (25 mm) next to the stop bracket using self-tapping screws $\frac{1}{4} \times 1$ in. (6.3 x 25 mm). Please note that the rubber bumper on the crab should almost hit the stop bracket when the CRS Auto Return Switch is activated. Refer to fig. 4.3.8.

- Mount the second CRS Auto Return Switch bracket on the other end of the rail using self-tapping screws $\frac{1}{4} \times 1$ in. (6.3 x 25 mm).

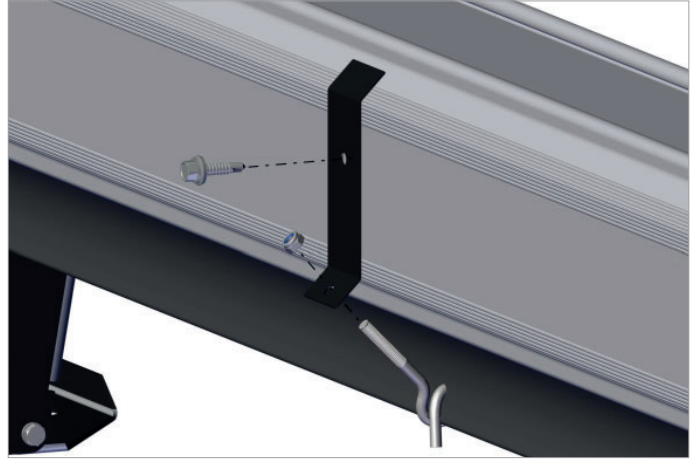


Fig. 4.3.9 Mounting the rope bracket

- Mount the rope bracket(s) using self-tapping screws $\frac{1}{4} \times 1$ in. (6.3 x 25 mm). Mount the rope brackets equally divided over the rail. Refer to fig. 4.3.9.

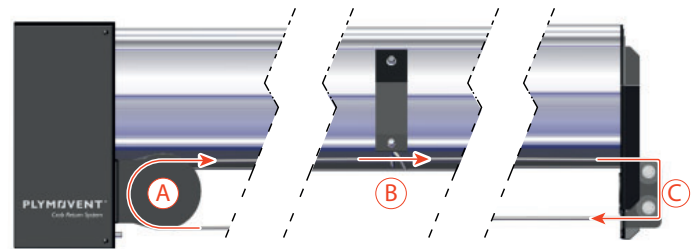


Fig. 4.3.10 Installing the rope

Refer to figures 4.3.10.

- Guide the rope over the pulley wheel (A), through the rope brackets (B), and over the guide wheels (C).

Refer to figures 5.3.10 and 5.3.11.

- Attach one end of the rope to the rope eye bolt (D) and tighten the wire clamp (E).
- Attach the other side of the rope to the spring (F) and tighten the wire clamp (H).
- Attach the spring to the rope eye bolt (G).
IMPORTANT: Make sure to place the spring under 1 in. (25 mm) of tension. Adjust the amount of tension by changing the rope eye bolts position (D and G) or the slack on the rope with the wire clamps (E and H).

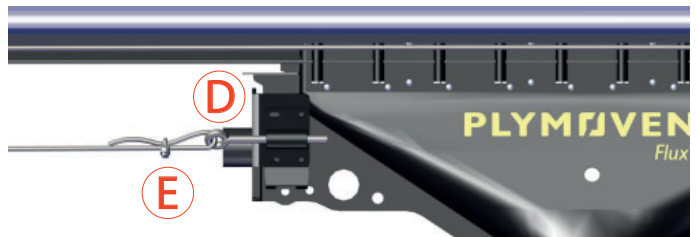


Fig. 4.3.11 Installing the rope

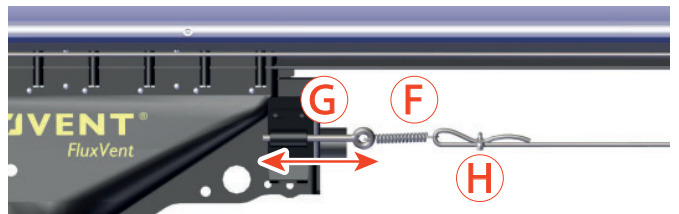


Fig. 4.3.12 Installing the rope

5.1 Unpacking

Make sure that the product is complete. The package contains:

 - CRS Auto Return Switch (stop)
 - CRS Auto Return Switch (start) (optional)
 - CRS Auto Return Switch bracket
 - two eye bolt connector plates with eye bolts (start/stop triggers and eye bolt connector)
 - remote control (emergency stop and manual return)
 - bracket set crab
 - fastening materials

5.2 Mounting instruction

The system is configured in such a way that the motor will pull the crab towards the motor compartment. In case you would like to switch the pull direction, switch the 2 motor leads. See the supplied electrical diagram. Please note that the side on which the Crab Return System will be mounted is fixed by the design of the motor compartment and placement of the pulley wheels. If the Crab Return System is used with a Pneumatic Grabber®, all required parts that are mounted on the rail and crab for the pneumatic system have to be on one side, and all parts for the CRS on the opposite side. It is advised to draw a layout prior to installation.

5.3 Installation

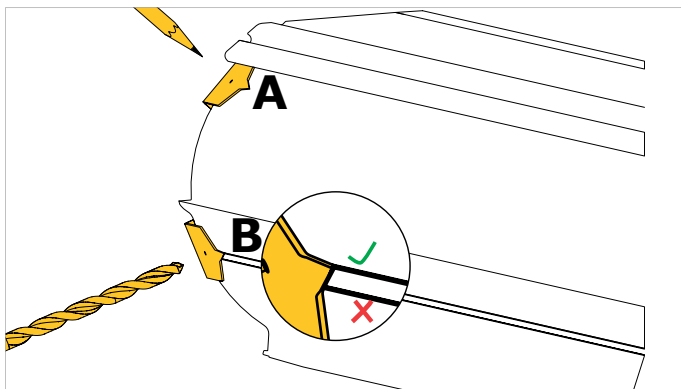


Fig. 5.3.1 Drill template on STR

- With the use of the drill template drill to mark and drill two 9 mm holes on each side of the rail. For hole A, place the drill template as high up in the groove as you can. For hole B, place the tip of the drill plate in the top groove. Refer to fig. 5.3.1.
- Repeat this step for the other end of the rail.

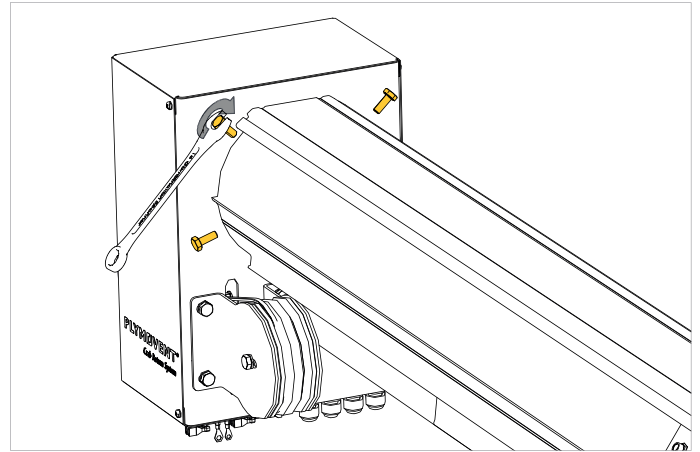


Fig. 5.3.2 Mounting the motor compartment to the rail

- Mount the motor compartment to one end of the rail, and secure with 4x M8x20 bolts and 4x M8 washers using wrench 13 (½ in.). Refer to fig. 5.3.2.

TIP

Mount the end plate of the CRS after the crab has been prepared and installed.

- Attach both eye bolt connector plates to the crab using 4x M4x20 bolts for each plate.

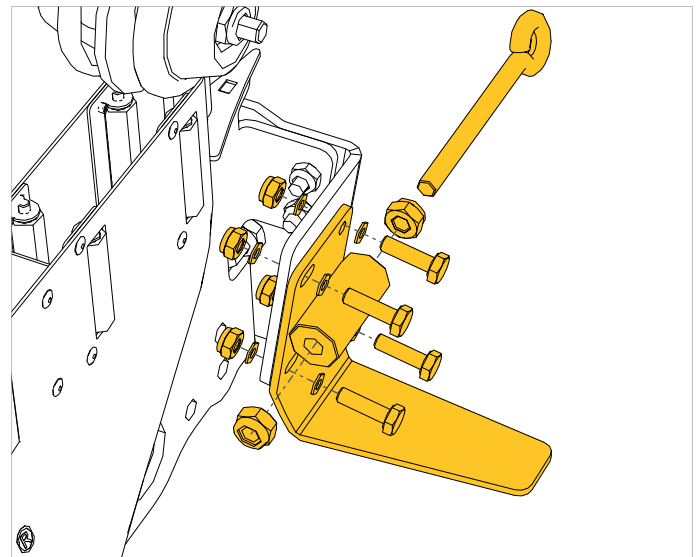


Fig. 5.3.3 Mounting the rope brackets on the crab

NOTE: In the case of an existing system with an older crab, make sure to predrill holes in the crab! Refer to fig. 5.3.3

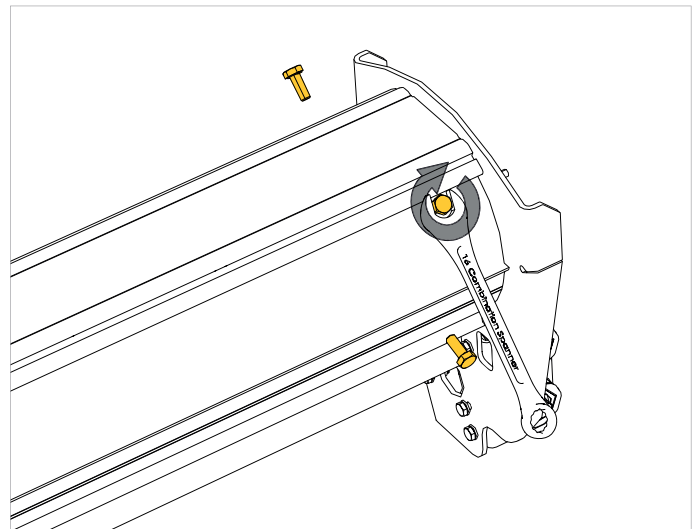


Fig. 5.3.4 Mounting the cover plate

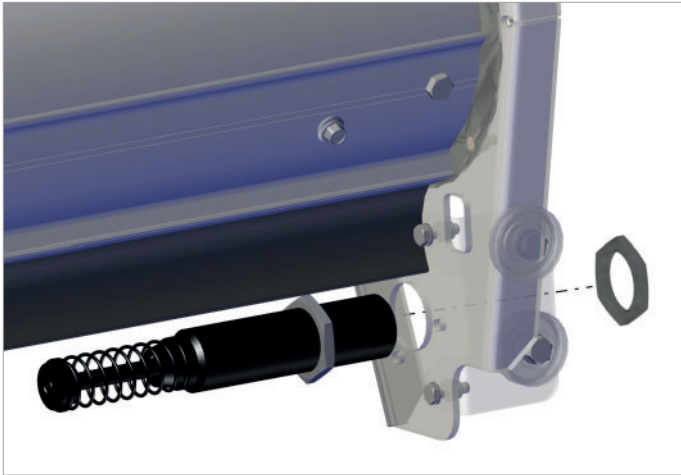


Fig. 5.3.5 Mounting the hydraulic shock on the cover plate

- Mount the shock (or hydraulic shock absorber) on the coverplate with the provided fastening materials. Refer to fig. 5.3.5

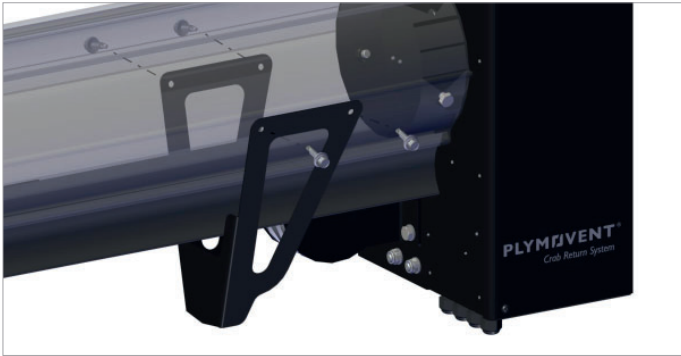


Fig. 5.3.6 Mounting the stop bracket

- Mount the stop bracket to the rail using self-tapping screws $\frac{1}{4} \times 1$ in. (6.3 x 25 mm). Refer to fig. 5.3.6.

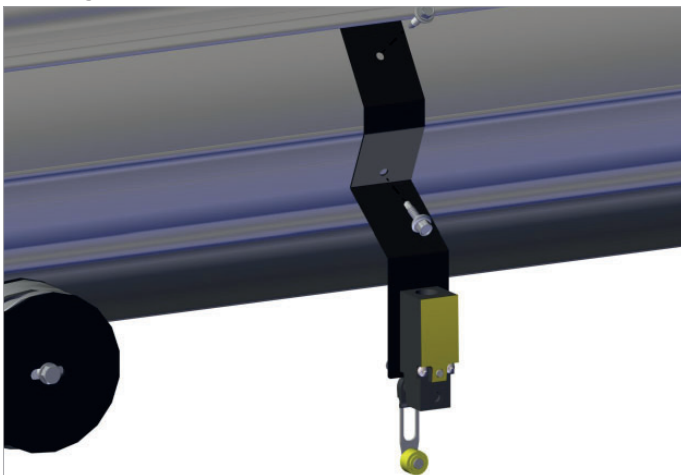


Fig. 5.3.7 Mounting the CRS Auto Return Switch bracket

- Mount the CRS Auto Return Switch bracket 1 in. (20 mm) next to the stop bracket self-tapping screws 6,3 x 25. Refer to fig. 5.3.7.

- Mount the second CRS Auto Return Switch bracket on the other end of the rail using self-tapping screws $\frac{1}{4} \times 1$ in. (6.3 x 25 mm).
- Mount the rope bracket(s) using self-tapping screws $\frac{1}{4} \times 1$ in. (6.3 x 25 mm). Refer to fig. 5.3.8.

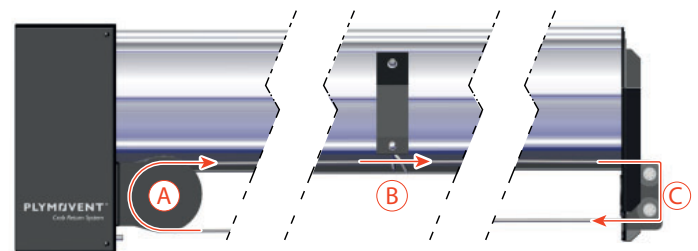


Fig. 5.3.9 Installing the rope

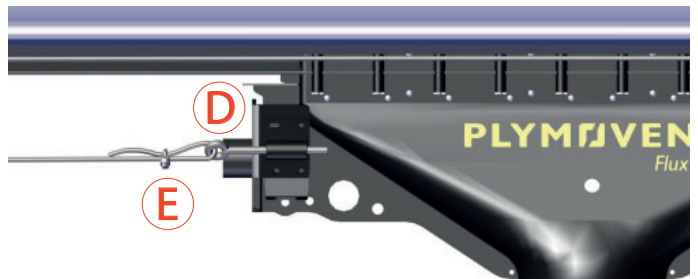


Fig. 5.3.10 Installing the rope

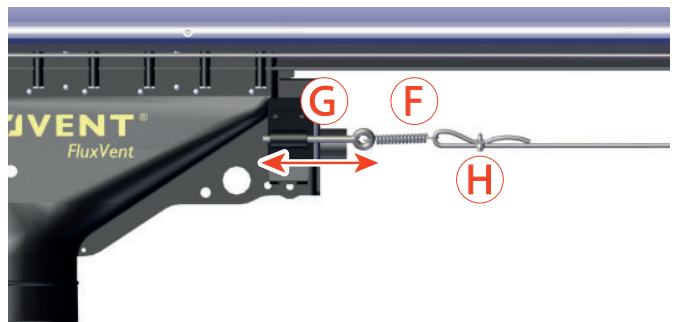


Fig. 5.3.11 Installing the rope

 - fastening materials

- Repeat this step for the other end of the rail.

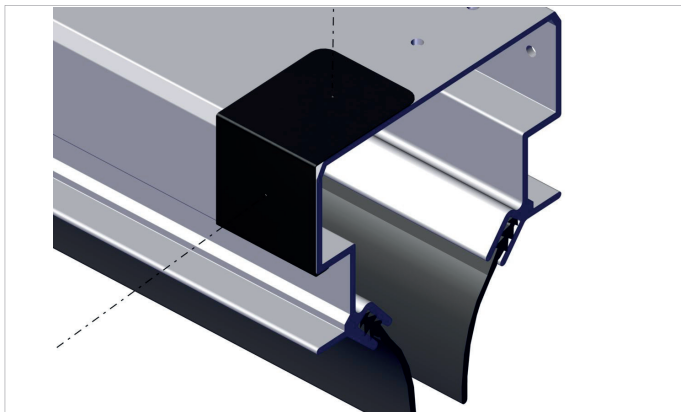


Fig. 6.3.1 Drill template on VSRX

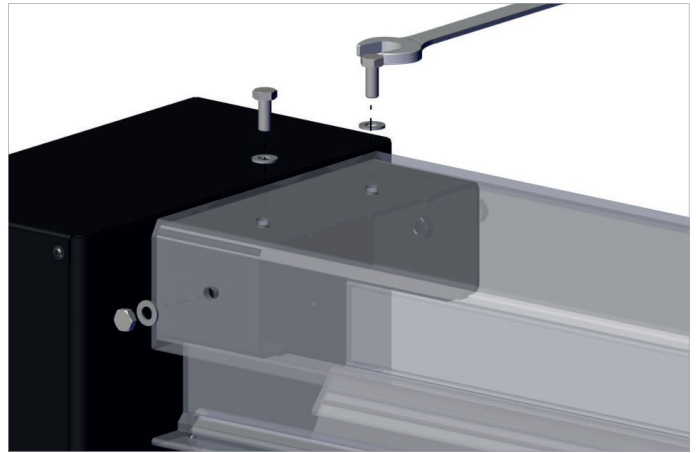


Fig. 6.3.2 Mounting the motor compartment to the rail

- Mount the motor compartment to one end of the rail, and secure with 4x M8x20 bolts and 4x M8 washers using wrench 13 (½ in.). Refer to fig. 6.3.2.

Mount the cover plate of the CRS after the crab has been prepared and installed.

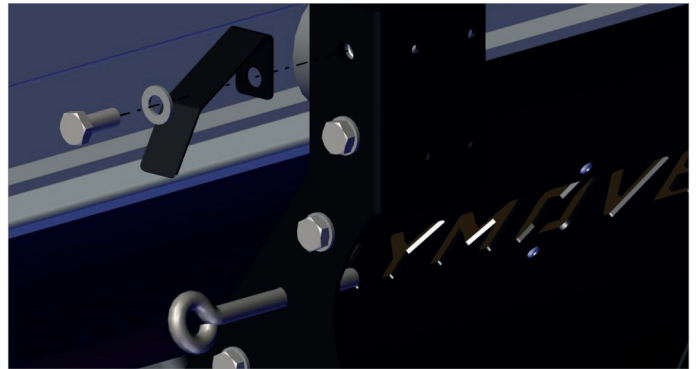


Fig. 6.3.3 Mounting the start/stop bracket on the crab.

- Mount the start/stop bracket to the crab using self-tapping screws ¼ x 1 in. (6.3 x 25 mm). Refer to fig. 6.3.3.

- Mount the curl hooks for the rope on the crab using self-tapping screws ¼ x 1 in. (6.3 x 25 mm) Refer to fig. 6.3.4..

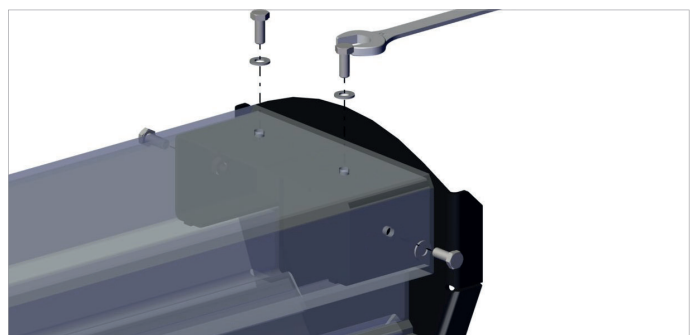


Fig. 6.3.5 Mounting the cover plate

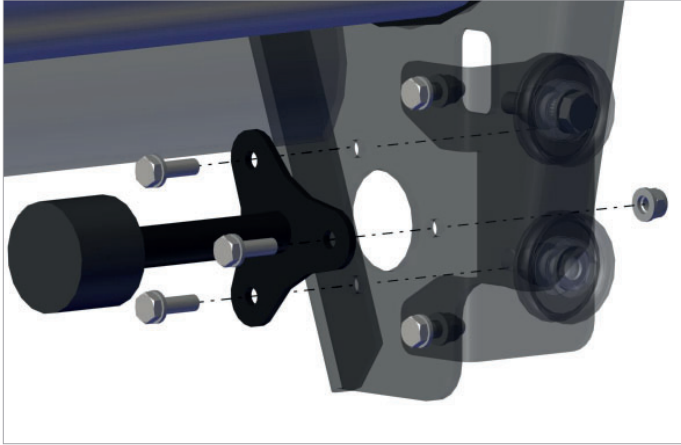


Fig. 6.3.6 Mounting the shock on the cover plate

- Mount the shock (or hydraulic shock absorber) on the coverplate with the provided fastening materials. Refer to fig. 6.3.6

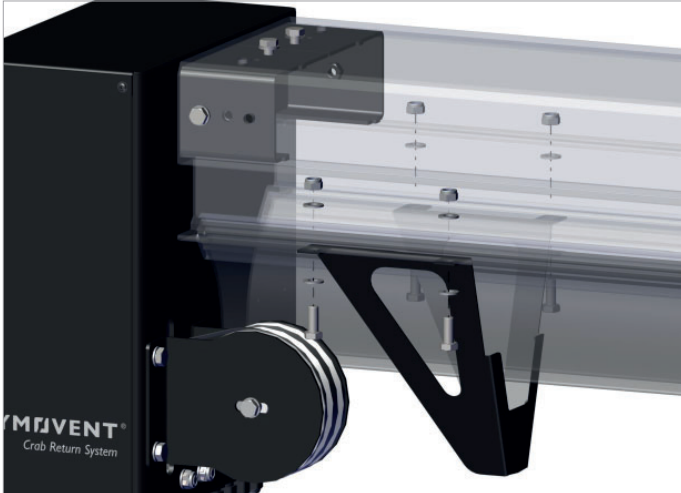


Fig. 6.3.7 Mounting the stop bracket

- Mirror the CRS Auto Return Switch and repeat this step for the other end of the rail.

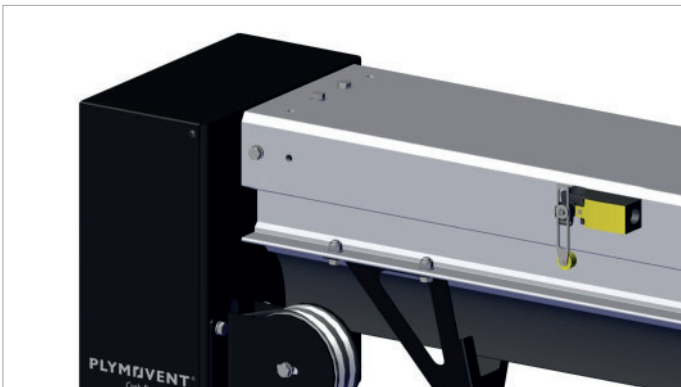


Fig. 6.3.8 Mounting the CRS Auto Return Switch

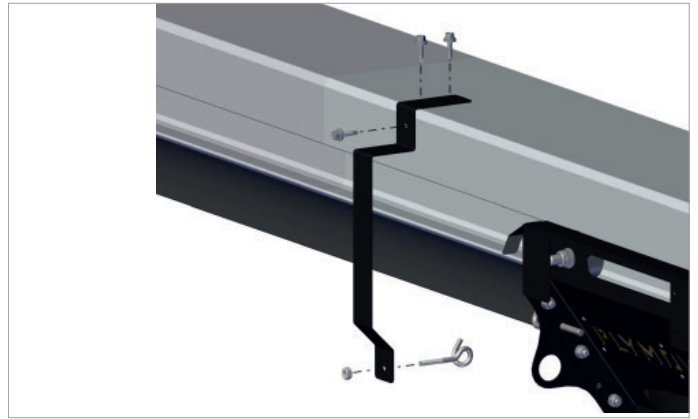


Fig. 6.3.9 Mounting the rope bracket

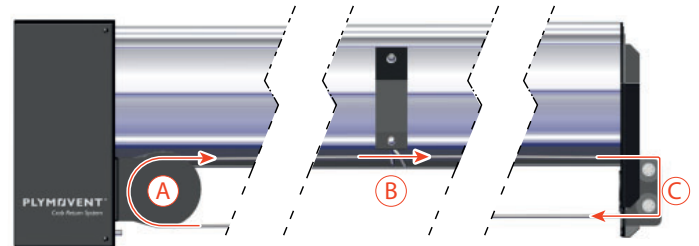


Fig. 6.3.10 Installing the rope

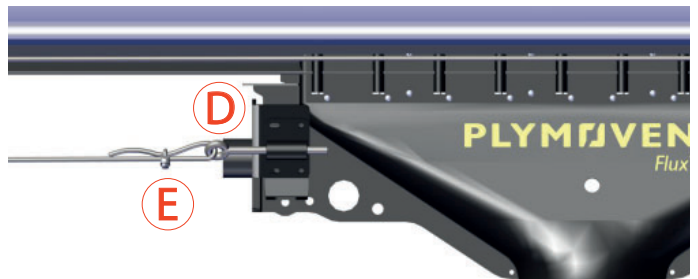


Fig. 6.3.11 Installing the rope

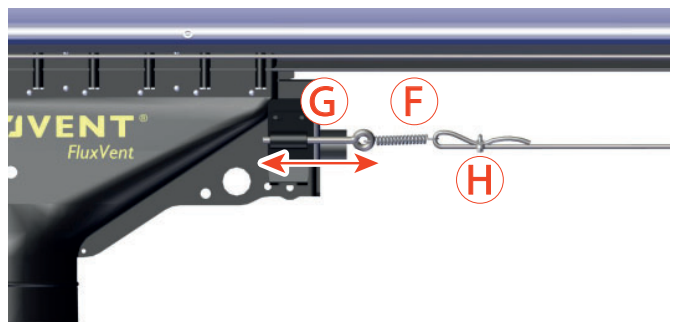


Fig. 6.3.11 Installing the rope

6.3 Electrical connections

- Make the electrical connections according to the supplied electrical diagram.

7 USE

- Push the start button of the CRS to return the crab to the starting position.
- Push the emergency stop to stop the CRS if required.
NOTE: release (all) the emergency stops by turning the stop to the right and pulling it out to use the CRS again.



ATTENTION

Always make sure the nozzle is disconnected from the vehicle before returning the crab using the CRS.



ATTENTION

Make sure the airflow in the rail is terminated by shutting down the fan or closing the (optional) automatic damper when the crab is returning (slip might occur).

8 MAINTENANCE

8.1 Periodic maintenance

The product has been designed to function for a long time. In order to guarantee this, regular maintenance activities are required which are described in this chapter.

The indicated maintenance intervals can vary depending on the specific working and ambient conditions.

Therefore we recommend to have the complete product inspected once every year besides the indicated periodic maintenance. For this purpose contact your supplier.

	Loose contacts	Inspect the contacts

The start button or return actuator on the rail is activated but the system does not move	The rope	Adjust the tension of the rope
	The emergency stop is activated	Release the emergency stop
	The power supply is overheated	The power supply will restart after 15 seconds
	The V-belt	Adjust the tension of the V-belt with the micro switches (refer to spare part drawing)

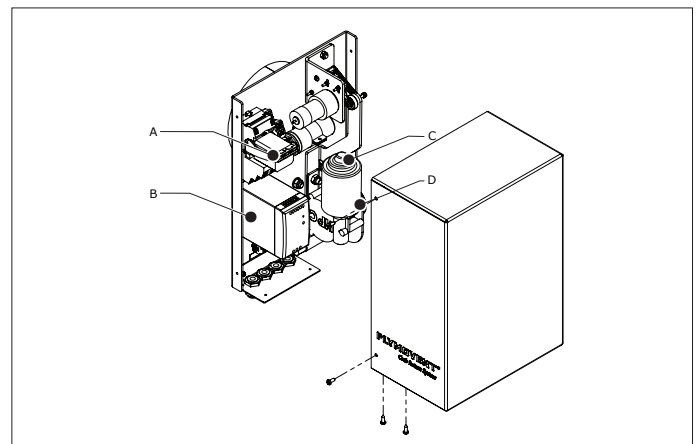


Fig. 10.1 Spare parts
