### From targets to action (1/4)

# GHG Emissions and Energy Efficiency

We are committed to the goals of the Paris Agreement and to transforming Plymovent into a net zero company by reducing our greenhouse gas emissions and minimize our overall carbon footprint. We do that by taking action and investing in:

- Paris Agreement Goals: We're dedicated to becoming a net zero company by reducing greenhouse gas emissions and minimizing our carbon footprint.
- **Strategic partnerships:** Teamed up with Climate Neutral Group for a net zero roadmap.
- **Global carbon assessment:** Conducted carbon footprint assessments for all Plymovent offices worldwide.
- Targeted emission reduction: Implemented quick, efficient emission-cutting strategies.
- **Tailored plans:** Crafted office-specific emission reduction plans in sync with our business cycle.
- **Sustainability recognition:** Earned a Bronze medal for the EcoVadis sustainability assessment, next step: Gold.
- Sustainable energy: our Alkmaar offices and European distribution centre run 100% off the grid thanks to 1,650 solar panels and geothermal heating (2022). Thailand factories also use solar panels, generating surplus electricity.
- Energy efficiency: Improving insulation and reducing air conditioning use.
- **Smart lighting:** LED and motion sensors installed across most Plymovent offices and warehouses.
- **Eco-friendly Practices:** Ditched printed materials and giveaways, opting for electronic communication to reduce paper use.
- Environmental Impact: Planting a tree with 'Ecodrive', a non-profit organisation focused on global reforestation, for every business card received at our exhibitions.
- Reduced Travel: Streamlining service operations and exploring low-impact service concepts.

### From targets to action (2/4)

### <sup>2</sup> Water management

In Plymovent's production process, requires minimal water. Simultaneously, we are mindful of the value of water in our precious world. Water is a vital and shared resource that needs to be protected. In our water usage practices, we primarily rely on groundwater. The water we use for toilets and human consumption is separate from industrial waste, adhering to responsible water management. In our production locations, we use septic tanks that are emptied by a certified subcontractor, ensuring responsible and sustainable wastewater management.

### From targets to action (3/4)

### 8 Resources and waste

At Plymovent, we predominantly generate non-hazardous waste. For all waste, we created a proper internal waste management procedure aligned with laws and regulations for the handling and disposal of waste from our operations, minimizing the risk of potential spills. Besides we invest in:

- Plastic and foam reduction initiatives and explore more sustainable packaging alternatives, across all our production and assembly locations. Research & Development (R&D) plays a crucial role in driving this significant change.
- Usage of recycled carton material. Currently, 90-95% of our carton used is recycled.
- Sustainable design principles into our Research & Development organisation, especially in material choices.
- Supplier environmental evaluation and close collaboration during product design to get their input on how to reduce the environmental impact of our products.

### Product Stewardship and Circular Economy

We have the ambition to go beyond just delivering high-quality, top-notch product solutions. We want to be pioneers in providing solutions that drive our customers toward a sustainable, more circular future. Finding alternative raw materials and lower-emission production technologies are key elements in securing our mission.

Our product line carries high-quality, durable, and reliable air-cleaning solutions, crafted without the usage of hazardous raw materials. Our design philosophy revolves around integrating recyclable materials whenever possible. In our quest for continuous improvement, we continuously improve the energy efficiency of our products while minimizing size and weight to reduce the raw material consumption and environmental impact of our products.

And that is exactly how we roll at Plymovent!
